1. Called meeting to order at 7:05 p.m. at 2379 VanDyke, Conklin, Michigan.
2. Agenda Approved with addition of Weed/Algae Update. (Motion by Bruce Callen; seconded by Susan McClure).
3. Secretary Report Approved. (Motion by Bruce Callen; seconded by Pat Wolters)
4. Treasurer's Report Approved. (Motion by Linda Lane; seconded Dennis Arms) Pat gave Bob the information to send the Michigan Riparian subscription bill in. Bob will write a check for this.
5. Weed/Algae Update. There will be a treatment the last week of June and possibly another one if necessary before July 3.
6. Wendy Ogilvie discussed the overall purpose of LGROW and how our lake fits into the Grand River watershed. She made suggestions regarding restoring Little Crockery Lake wetlands, rerouting of drains, failing septic, geese management and shoreline erosion.

Asking for volunteers on July 4 at 8 am to pick up after fireworks at Gunkels.

9. Updated Welcome signs. Bruce showed us a revised proposed sign. Suggested change: Add white background highlighting on lettering. Bruce to discuss aluminum reinforcements for backs of signs with Chuck Lane. July newsletter will include picture of proposed sign and ask for comments from lake residents. Bruce will get us costs for the signs. We are hoping for lake resident donations. We will be asking via newsletter if there is anyone interested in doing any landscaping by the signs.
